**WHEREAS**, the Dehcho First Nations Leadership came together for a Special Leadership Meeting on January 22-24<sup>th</sup>, 2007 in Fort Simpson; and

**WHEREAS**, the Government of Canada has passed the Mackenzie Gas Projects Act for the mitigation of Mackenzie Gas Project impacts. The Act sets up a \$500 million Mackenzie Gas Projects Impacts Fund (also known as the Socio-economic Impact Fund); and

**WHEREAS**, the Dehcho First Nations Leadership has reviewed the information that has been presented on the Mackenzie Gas Project Impact Fund, and

**WHEREAS**, there is still planning work that must be completed, and

**WHEREAS**, the Dehcho First Nations Leadership without prejudice to the Dehcho Process is prepared to move forward on the Mackenzie Gas Project Impact fund;

**WHEREAS**, DFN passed Motion # 02-13/09/05 agreeing to accept a 30% share of the Socio-economic Impact Fund at their leadership meeting in Fort Providence; and

**WHEREAS**, DFN passed Motion # 04-Nov 09, 2005 mandating the DFN as the Regional Organization (Regional Legal Entity) to manage and administrate the regional affairs of the Fund at their leadership meeting in Fort Simpson; and


