<b>ISSUE</b>	<b>CONCLUSION</b>
<b><u>Eligibility and Enrolment</u></b>	<ul style="list-style-type: none"> <li>• <u>General</u>: LTC to look at ways to clarify that there will be an Initial Enrolment Period to take place within the 18 month period referenced in E.2.5 and to also perhaps reinstate the deleted E.2.6</li> <li>• <u>E.2.5 and E.2.9</u>: language needs to be cleaned up to clarify that the PEL publications referred to in both these provisions are the same</li> </ul>
<b><u>Ratification</u></b>	<ul style="list-style-type: none"> <li>• <u>General</u>: Need to clarify when the ratification committee is going to begin. In E.2.11 it occurs when the PEL is handed to the Ratification Committee but in R.1.5 it is “no later than 6 months prior to the initialling of the Final Agreement”.</li> </ul>
<b><u>Social Housing</u></b>	<ul style="list-style-type: none"> <li>• <u>General</u>: DFN requested and GNWT agreed to insert footnote on definition of Social Housing to clarify that social housing includes public housing.</li> </ul>
<b><u>Post Secondary Education</u></b>	<ul style="list-style-type: none"> <li>• <u>GPX.X</u>: agreement to move to General Provisions chapter</li> <li>• <u>L&amp;H X.X</u>: agreement to move to Culture, Heritage and Language chapter.</li> </ul>
<b><u>Community Governance:</u></b>	<ul style="list-style-type: none"> <li>• <u>General</u>: Add “Dehcho” to Community Government in C.G 9</li> <li>• <u>CG9.1</u>: GNWT proposed new language “A new community under the jurisdiction of the Dehcho Regional Government will only be established by agreement among the Parties.” Agreement to</li> </ul>
